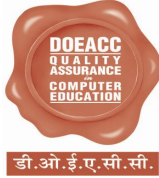

- Proof of your Experience (Original with an attested copy)

If you fail to produce the above documents at the time of Test/Interview, you will not be allowed to attend the Test/Interview, nor will TA be paid to you.

3. **You are requested to reach the Centre latest by 08.30 AM on 27.03.2009** and are also required to produce the following documents, failing which you will not be allowed to appear for the Test/Interview:

- b) All original Documents/Certificates/Testimonials in respect of your age/qualifications [includes Mark list, original Pass Certificate, etc] Percentage of Marks/Experience/Caste Certificate in appropriate format in case of ST/OBC etc.
 - c) 'No Objection Certificate' if the candidate is employed in Central Government/State Government/PSUs/Autonomous Bodies and his/her application was not forwarded through proper channel.
 - d) The enclosed Bio-data form, duly filled in
4. Outstation candidates attending the Test/Interview will be paid to and from second class Train fare from the place of residence to Calicut by the shortest route on production of journey ticket or photocopy thereof. In respect of places not connected by rail, ordinary bus fare will be paid.
5. You have been **shortlisted** for the Test/Interview on the basis of the **data/information** furnished by you in your application form.
